- 4. Council of Administration will meet at 3:00pm, January 7, 2023, at the Mid-Winter Conference in Reno, Nevada.
- 5. Commander's and President's Homecoming shall be at 5:00pm, September 17, 2022, at Post 10054, 4651 Homestead Pl. Pahrump, Nevada.
- 6. Department Mid-Winter Conference shall be 08:00, January 6-7, 2023, at the TBA, Reno, Nevada.
- 7. Department State Convention shall be 09:00, June 14-17, 2023, at the Red Lion Inn, Elko, Nevada.
- 8. Buddy Poppy Orders are to be made in writing (email or mail) to the Department Quartermaster. Buddy Poppy orders are to be paid no later than January 6, 2023.
- 9. Commanders, Adjutants, and Quartermasters at all levels review Sections 216, 416, 516, and 703 of the National Bylaws Bond of Accountable Officers and comply by August 31, 2022.
- 10. Commanders shall complete and submit to the Department Adjutant a completed Department Code of Ethics Policy Acknowledgment form no later than August 31, 2022.
- 11. Commanders, Adjutants, and Quartermasters at all levels are reminded that Governmental Law supersedes VFW Bylaws and strict compliance must be enforced to include operation of Post Homes and Canteens to include internal Revenue Service regulations governing nonprofit charitable organizations, State of Nevada, and local laws.
- 12. Commanders, Adjutants, and Quartermasters at all levels are remined that Section 709 of the National Bylaws requires that any funds generated for any level of activity for the Post, District, or Department must be placed in the care and custody of the respective Quartermaster.
- 13. Commanders, Adjutants, and Quartermasters at all levels review Section 704 of the National Bylaws and Manual of Procedure which outlines uses of the Post Relief funds.

- 14. Commanders, Adjutants, and Quartermasters at all levels are reminded that under Section 708 of the National Bylaws each Post needs to be incorporated with the Nevada Secretary of State.
- 15. Each Post shall submit an "Annual List of Officers" to the State of Nevada Secretary of State no later than the last day of the Post's incorporation date.
- 16. Commanders, Adjutants, and Quartermasters at all levels your attention is direct to Articles XI Auxiliary, Section 1101(f)(3) and XII Military Order of the Cootie, Section 1201(e)(2), that require subordinate units of your Post to make an Annual Report to the Post Commander of its financial and membership status. These reports are due within 30 days after induction into office.
- 17. The State Quartermaster shall reimburse members only for a completed expense report with receipts, as specified in the Department Bylaws, Sections 1102 and 1502. Requests for expenses incurred in support of a Department Officer or Chair must have his or her approval in writing before the State Quartermaster shall reimburse any incurred expenses.
- 18. District Commanders/Inspectors shall complete Post Inspections and submit the completed reports to the Department Inspector by December 15, 2022.
- 19. All-State Added to the requirements for All-State for Posts and Districts Each Post and District is required to conduct two (2) recruiting events during the year. These recruiting events shall be reported using the All-American Dashboard (also known as the Program Dashboard). This will be tracked on the Department Admin and All-State Report.
- 20. Post, District, and Department officers and all members are reminded they are expected to conduct themselves in a manner that is becoming of a member. This includes abiding by the laws of Nevada, particularly those pertaining to drinking and driving, sexual harassment, and assault and battery. Those who do not could be subject to Article IX disciplinary action. Post Commanders are directed to read this paragraph of the order to their Posts at the first meeting after receipt of General Order # 1, and those Posts with owned property, this paragraph must be clearly mounted in all areas accessible to the members.
